

§ 93.03 SIDEWALKS; SNOW, ICE, DIRT, AND GARBAGE REMOVAL.

(A) *Snow and ice removal.* Every owner, tenant, or occupant of any premises abutting or bordering on any street in the city shall remove, or cause to be removed, all snow and ice from the sidewalks in front of those premises to the full paved width of the sidewalks. If the snow and/or ice shall freeze so hard that it cannot be removed, then the sidewalk must be made safe by sprinkling it with salt, sand, ashes, or other material.

(B) *Garbage or dirt.* No person shall throw or cause any garbage, dirt, or stones to be thrown upon any sidewalk. Such an action shall be a public nuisance.

(C) *Violations.* Persons violating this section shall be fined an amount payable through the Ordinance Violations Bureau, as discussed in Chapter 36 of this code.

§ 93.06 CARRYING TRASH INTO CITY PROHIBITED.

It shall be unlawful to carry into the city from areas outside the city limits any domestic garbage, trash, refuse, or odd-sized trash to be picked up by the city Department of Streets and Sanitation or a contracted refuse collector.

§ 93.07 ACCUMULATION OF JUNK OR DANGEROUS OR OBNOXIOUS MATTER PROHIBITED.

(A) Except for premises permitted for that use under the terms of the city Zoning Ordinance, it shall be unlawful to accumulate or allow the accumulation, upon any premises within the corporate limits of the city, of garbage, ashes, refuse, rubbish, manure, carcasses, junk, automobile parts and bodies, tires, junk appliances, bedding, junk furniture, junk machinery, clippings from growth, old newspapers, and all other kinds and types of organic or inorganic materials generally classified as junk or refuse; provided, however, that nothing herein contained shall prevent the accumulation and storage of items of value which are stored in a secured building out of the sight of the public and the occupiers of adjoining property when that storage does not constitute a health or fire hazard, and provided further that this section shall not prevent the accumulation and storage in the manner provided by law of items to be picked up by the Department of Streets and Sanitation of the city.

(B) It shall be the duty of the Chief of Police or his or her designee to notify the owners and occupying tenants of any property found to have accumulations in violation of division (A) to remove any such accumulations from the premises within a reasonable time not less than ten days but not to exceed 30 days. In the event the accumulation has not been removed within the period designated by the Chief of Police, the Department of Streets and Sanitation is authorized to enter upon the premises and remove the unlawful accumulations. The cost of removal of the unlawful accumulations shall be a lien upon the real estate from which those accumulations are removed, and the Streets and Sanitation Commissioner shall certify the costs of the removal to the City Clerk-Treasurer, who shall in turn certify the costs to the Treasurer of the county in question for collection in the same manner as real estate taxes are collected upon the premises.

(C) Any person, firm, or corporation violating the provisions of division (A) hereof or failing to

comply with the order of the Chief of Police for the removal of any unlawful accumulation as provided in division (B) hereof shall, upon being found guilty, be fined, which fine shall be in addition to the imposition of any liens in the manner provided by this section.

§ 97.03 LITTERING, DUMPING, AND POLLUTION PROHIBITED.

(A) No person shall take into, carry through, leave in, or throw, cast, lay, drop, or discharge into or on, or suffer or permit any servant, agent, employee, person, or animal in his or her charge to take into, carry through, leave in, throw, cast, lay, drop, or discharge into or on any park or park street any rubbish of any sort. The leaving, except in receptacles provided for refuse, or the leaving or littering of newspapers, or other papers, in a park is prohibited. No person shall throw, cast, lay, or deposit any bottle or piece of crockery or any glass or glassware or any part thereof, or metallic or other substance with sharp edges or projections in any park.

(B) No person shall throw, cast, lay, drop, or discharge into or leave in the waters used for swimming or water in any park or in any storm sewer, or drain flowing into those waters, any substance, matter, or thing, liquid or solid, which may or shall result in the pollution of the waters.
